- Requests for introductions, funding, or services should be made thoughtfully and with consent.

- This is a safe space for all female founders regardless of background, ethnicity, religion, or industry.
- Discriminatory, offensive, or exclusionary behavior is strictly prohibited.

- Avoid excessive posting to prevent overwhelming the group.
